Remarks:

The Convertible Bond with an aggregate principal amount of RMB 85,000,000 was issued on 5 January 2026. The conversion period does not commence until 5 January 2029 and ends on 27 December 2030.

Assuming that the Convertible Bond is fully converted into Conversion Shares (H Shares) at the initial Conversion Price of RMB1.0, a total of 85,000,000 H Shares will be issued, representing:
 (i) approximately 39.5% of the issued share capital of the Company as at close of the month ; and
 (ii) approximately 28.3% of the issued share capital of the Company as at close of the month as enlarged by the Conversion Shares upon the exercise of the conversion rights attaching to the Convertible Bond in full.

The Bondholder shall not exercise any conversion rights to such an extent that results or will result in:

(i) the Bondholder and parties acting in concert with it will trigger a mandatory offer obligation under the Takeovers Code, unless (a) the Bondholder and parties acting in concert with it will make a general offer to all the Shareholders in accordance with the Takeovers Code; or (b) such implied general offer by the Bondholder and parties acting in concert with it to all the Shareholders will be waived by the Securities and Futures Commission; or
 (ii) less than 25% or the minimum prescribed percentage as set out in the GEM Listing Rules of the total issued Shares would be held by the public immediately after the relevant exercise of conversion rights.
